- Article 4, Section 4. Removal
  - Accepted

  - Changed language to specify Chair is limited to two consecutive terms in office
  - Accepted as amended

- Added language clarifying that Chair assists in creation of agenda with input from Board and Director

  - Add phrase "current edition"
  - Accepted as amended
- Article 7, Section 7. Quorum
  - Eliminated language specifying number of Members who must be physically present at a meeting
  - Accepted as amended
- Article 8, Section 2. Committees
  - Added language on Ad Hoc Committees
  - Budget and Finance Committee
    - Changed language to reflect earlier changes regarding creation of budget
  - Facilities Committee
    - Added using language from Seurynck
  - Executive Committee
    - Added language stating Committee makes recommendation to full Board in regards to evaluation of Director
  - Policy Committee
    - Removed from Standing Committees
  - Accepted as amended
